

## **RESOLUTION 22-04**

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2021-2022 BUDGET FOR THE RECEIPT OF UNANTICIPATED REVENUE; INCREASING THE CRA SPECIAL REVENUE FUND TO APPROPRIATE REVENUES AND EXPENSES RELATED TO THE RURAL BUSINESS SERVICES (RBS) PROGRAM OF THE UNITED STATES DEPARTMENT OF AGRICULTURE (USDA) GRANT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on April 7, 2021, an application was submitted to the RBS requesting a grant to supplement CRA funding of a new parking lot in downtown Alachua; and

WHEREAS, on July 22, 2021, the "Request for Obligation of Funds" was executed by the USDA.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF ALACHUA, FLORIDA:

**Section 1.** The Finance and Administrative Services Director is directed to amend the Fiscal Year 2021-2022 Budget by increasing the CRA Special Revenue Fund and appropriating the amount of one hundred fifty thousand dollars (\$150,000) as reflected in the budget amendment attached hereto as Exhibit A.

**Section 2.** That this resolution shall become effective upon adoption.
