

RESOLUTION 23-05

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2022-2023 BUDGET FOR THE RECEIPT OF UNANTICIPATED REVENUE; INCREASING THE ENTERPRISE FUND TO APPROPRIATE REVENUES AND EXPENSES RELATED TO THE GRANT RECEIVED FROM THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, City of Alachua staff had submitted a grant application to the Florida Department of Environmental Protection (FDEP) to design and construct a pressurized wastewater main and make improvements to existing lift stations; and,

WHEREAS, on November 22, 2022, the FDEP executed a grant agreement in the amount of \$850,000;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:

- 1. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2022-2023 Budget by increasing the Enterprise Fund and appropriating the amount of eight hundred and fifty thousand dollars (\$850,000) as reflected in the budget amendment attached hereto as Exhibit A.
- 2. That this resolution shall take effect immediately upon its adoption.
