

## **RESOLUTION 23-10**

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2022-2023 BUDGET FOR THE RECEIPT OF UNANTICIPATED REVENUE; INCREASING THE CHILDREN'S TRUST GRANT SPECIAL REVENUE FUND TO APPROPRIATE REVENUES AND EXPENSES RELATED TO THE CHILDREN'S TRUST OF ALACHUA COUNTY AGREEMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Children's Trust of Alachua County had issued Request for Proposals (RFP) 2022-03; and,

WHEREAS, the City, submitted an application in response to said RFP that met the needs and purposes of the RFP; and,

WHEREAS, the City Commission authorized execution of a contract between the Children's Trust of Alachua County and the City on March 28, 2022;

WHEREAS, the City Commission authorized the renewal of a contract between the Children's Trust of Alachua County and the City on February 13, 2023; and,

WHEREAS, the Children's Trust of Alachua County Board executed an amendment to the agreement to provide budget increases related to cost-of-living adjustments on May 3, 2023;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:

1. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2022-2023 Budget by increasing the Children's Trust Grant Special Revenue Fund and appropriating the amount of four thousand two hundred sixty-seven dollars (\$4,267) as reflected in the budget amendment attached hereto as Exhibit A.
