

**RESOLUTION 20-03**

**A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2019-2020 BUDGET; ESTABLISHING APPROPRIATION IN THE GENERAL FUND; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Alachua Police Department has been awarded a Justice Assistance Grant for the purchase of laptops/tablets; and

**WHEREAS**, it is necessary to increase the Fiscal Year 2019-2020 General Fund budget in the amount of \$20,157, to reflect revenues and expenses associated with the receipt of the Justice Assistance Grant.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:**

1. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2019-2020 Budget by the amount of twenty thousand one hundred fifty-seven dollars (\$20,157) as reflected in the budget amendment attached hereto as Exhibit A.
2. That this resolution shall take effect immediately upon its adoption.




