

RESOLUTION 20-07

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2019-2020 BUDGET FOR THE RECEIPT OF UNANTICIPATED REVENUE; ESTABLISHING THE CHILDREN'S TRUST GRANT SPECIAL REVENUE FUND TO APPROPRIATE REVENUES AND EXPENSES RELATED TO THE CHILDREN'S TRUST OF ALACHUA COUNTY AGREEMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission authorized submittal of a grant application to the Children's Trust of Alachua County for RFA 20-937 on December 9, 2019; and,

WHEREAS, the City Commission authorized the City Manager to execute an agreement relating to the grant award from the Children's Trust of Alachua County on February 24, 2020; and,

WHEREAS, , the City Manager executed said agreement with the Children's Trust of Alachua County was fully executed on June 8, 2020.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:

- 1. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2019-2020 Budget by establishing the Children's Trust Grant Special Revenue Fund and appropriating the amount of one hundred thirty-five thousand two dollars (\$135,002) as reflected in the budget amendment attached hereto as Exhibit A.
- 2. That this resolution shall take effect immediately upon its adoption.
