

RESOLUTION 21-06

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE CITY OF ALACHUA FISCAL YEAR 2020-2021 BUDGET; RECOGNIZING UNANTICIPATED REVENUE IN THE GENERAL FUND IN THE AMOUNT OF \$172,770; INCREASING GENERAL FUND APPROPRIATIONS WITHIN THE SPECIAL EXPENSE, CITY ATTORNEY, FACILITIES MAINTENANCE, BUILDING INSPECTIONS, AND SOLID WASTE BUDGETS BY \$172,770; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Intergovernmental Revenue (\$100,170) and Charges for Services (\$72,600) to be received during Fiscal Year 2020-2021 in the amount of \$172,770; and,

WHEREAS, the City Commission desires to appropriate these funds to address Fiscal Year 2020-2021 General Fund budgetary needs related to the Special Expense (\$10,000), City Attorney (\$20,000), Facilities Maintenance (\$60,000), Building Inspections (\$72,600), and Solid Waste Disposal (\$10,170) budgets in the amount of \$172,770.

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF ALACHUA, FLORIDA:

SECTION 1. The City of Alachua's Fiscal Year 2020-2021 Budget is amended to increase the total General Fund revenues and expenditures by \$172,770 as set forth in the attached budget amendment attached hereto as Exhibit A.

SECTION 2. The Finance and Administrative Services Director is directed to increase the Fiscal Year 2020-2021 General Fund Budget appropriation as set forth in the budget amendment attached hereto as Exhibit A.

SECTION 3. That this resolution shall take effect immediately upon its adoption.
