

RESOLUTION 21-01

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2020-2021 BUDGET; ESTABLISHING APPROPRIATION IN THE GENERAL FUND; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Alachua Police Department has been awarded a Justice Assistance Grant for the purchase of law enforcement equipment; and

WHEREAS, it is necessary to increase the Fiscal Year 2020-2021 General Fund budget in the amount of \$16,488, to reflect revenues and expenses associated with the receipt of the Justice Assistance Grant.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:

- 1. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2020-2021 Budget by the amount of sixteen thousand four hundred eighty-eight dollars (\$16,488) as reflected in the budget amendment attached hereto as Exhibit A.
 - 2. That this resolution shall take effect immediately upon its adoption.
